- Venue:** Austin Table Tennis Association, 8956 Research Blvd., Austin, Texas. Play will be on wood floor with good lighting and air conditioning.
- Equipment:** 16 tables: 11 European Stiga tables, Yasaka Master nets, 5 Butterfly tables orange 3 Star 40 mm balls. Only USATT approved equipment will be used.
- Clothing:** The USATT dress code applies. The primary color of shirts/shorts/skirts must be significantly different from the color of the balls used (orange). Non-marking rubbers soled shoes must be worn.
- Rules:** All USATT regulations apply. Matches will be best of 5, 11 point games.
- Eligibility:** Open to all members of USATT. Non-members can join when you enter the tournament by sending your membership fee along with your entry fee. Annual membership is \$40. Juniors (under 18) may join for \$20.
- Format:** **Singles Events: Open, U2400, U2200, U2000, U1800, U1600, 1400 and U1200.** Each event will be round robin to single elimination. The number of round robin groups in each event will be determined by the number of entrants, with a minimum of two groups. The top two finishers in each round robin group will advance to the single elimination phase. Final matches should be over by 8 pm. Prize money will be awarded to the top two finishers of the Open and U2400 events. Trophies will be awarded to the top two finishers of all other singles events. Players may enter up to three singles events but may not enter events that begin at the same time. **Each event is limited to 16 players.**
- Doubles: U3900 and U3300.** The events will be round robin to single elimination. Medals will be awarded to the top two teams of each event.
- Reporting:** Players must register at the desk at least 30 minutes prior to the start of their first event.
- Practice:** The facility will be open on Friday, February 19, at 7 pm, and on Saturday, February 20, at 8 am.
